ELIGIBILITY RULES AND REGULATIONS

1. All contestants must be a registered NEFFUL distributor of NEFFUL USA, INC. All contestants 18 and under must register for NEFFUL'S GOT TALENT under their parent or legal guardian's distributorship of NEFFUL USA, INC.
2. All contestants must prepare a 2-3 minute demo recording of talent/performance and submit it by mail or drop off to:

Deadline for submitting your demo recording and registering for NEFFUL'S GOT TALENT competition is November 20, 2009 at 5:00 PM PST. We will not accept late entries. No exceptions.

We will accept DVD demo recording only. Please submit disc labeled with your name, act name/group name, address, phone number, and distributor ID number along with this completed and signed Registration Agreement and the Contestant Information Sheet. Copies of these forms can be downloaded by visiting www.neffulusa.com.

All demo recordings submitted will not be returned. By entering competition on signed registered agreement you give full consent for the use of recording demo of your performance at the discretion of NEFFUL and producers. Please make a copy of your demo recording before submitting for your records.

3. Singing Performances – Singers are required to sing a cappella in demo recording and audition for review screening purposes. If voted TOP 20, TOP 10, or TOP 5 your live performance can be with or without music.
4. Songwriters, Musicians, Rappers can sing/rap to a track of an original work or cover and/or play your own instrument(s). If your performance requires using a backing track (not singers — see number 3) please mention its use in your demo recording and bring your own CD if voted TOP 20, TOP 10, or TOP 5 for your live performance.
5. Bands or Group Performances — At least one member of the band or group performance must be a registered NEFFUL Distributor. Bands of 5 members will only be allowed to participate. If you are in a band, please know you are responsible for your own equipment and fellow band members. No equipment will be provided at any live performance or audition. Please assume to bring all equipment needed for your performance.

6. Child Performances (18 and under) – Everyone under the age of 18 must participate under a parent or legal guardian who is a registered NEFFUL distributor of NEFFUL USA, INC. The NEFFUL distributor must be visible in the demo recording of the child's talent/performance and must be present at any and all auditions, rehearsals, live performances, and/or NEFFUL'S GOT TALENT meetings if called upon. The parent or legal guardian that is a registered Nefful distributor is responsible for child under all circumstances throughout the competition.
7. No Animal performances will be allowed.
8. No fire, sharp objects, weapons or explosives (pyrotechnics) are allowed in performance.
9. NEFFUL Producers and/or staff of NEFFUL'S GOT TALENT reserves the right to refuse a any entry or demo recording to any individual or act for any reason or no reason at all, at the sole discretion of NEFFUL producer and/or staff.

COMPETITION INFORMATION

Winning Prize

The winner of NEFFUL'S GOT TALENT will receive \$5000 Nefful Gift Certificate and a \$5000 Cash Prize. Prize will be granted at the 8th Annual Awards in August 2010.

Scanning Process

All demo recording entries will be sent through a scanning process for review and eligibility. Those who are selected will receive a call back to enter the audition process.

Audition Process

After the scanning process has been completed those who are selected will be called back for an audition where contestant will perform their talent and answer interview questions. The grant of an audition after the scanning process is completed does not guarantee the continuation of the competition. NEFFUL producer reserves the right, to make cuts at any time during the competition

Voting

TOP 20, TOP 10, and TOP 5 Voting Periods will be open and conducted through the NEFFUL'S GOT TALENT competition website. All votes will require a valid email address. At the time of voting it is wise to be a NEFFUL'S GOT TALENT subscriber to receive email notifications and reminders when voting poles open and close and for any updates. An announcement will be made on www.neffulusa.com for those who wish to subscribe to the NEFFUL'S GOT TALENT competition email updates.

Voting for the WINNER (from the TOP 5) will be conducted during the 8th Annual Awards in August 2010.

Live Performances

There will be 3 live performances in front of an audience in which the finalist must be present. Failure to be present for live performances, rehearsals and prior meetings etc. will result in disqualification from the competition.
