1. We will issue your access password via email supplied above. January 2006 will be the tentative launch date.
2. Web access charge starting April 1, 2006. Access website <https://secure.enefful.com/portal/>
3. You agree Nefful USA Inc. charge access fee USD \$5.00 on every 1st day of the month.
4. There will be no notification of said declined credit card. (If any information related to your credit card has changed, e.g. expiration date, account number, etc., please advise us as soon as possible to avoid your access being canceled or delayed.) It is the sole responsibility of the Distributor to inform Nefful of any problems with the credit card, prior to processing date.
5. Any program cancellation for nonpayment may act as a permanent ban from participation in the program.
6. You may cancel the program within 72 hours of the first time granting of service access, which may be prior to being charged in many cases. Whether you have been charged or not, this is the only time that you may cancel for any refund. You are free to cancel at anytime upon written notification to company; however, there will be no refunds for the program other than the 72 hour initial period.
