

Term of Use of Gift Voucher



- i. Purchasers who qualify for Sets 1, 2 or 3 shall receive Gift Voucher of the designated value.
- ii. The validity period of the Gift Voucher redemption is from 07/01/2021 to 07/29/2021, applicable for walk-in purchase, e-mail and/or fax orders only.
- iii. Purchasers are required to notify the usage of Gift Voucher to the Customer Service Team upon order submission. Gift Voucher will not be used if Purchaser failed to notify the abovementioned to the Customer Service Team.
- iv. The Cash Voucher is an entitlement to the purchaser. The purchaser can do a one-time transfer in full amount only if required, in condition that the transferee is within the same organization. Transfer of partial amount is not allowed. Cash Vouchers cannot be exchanged for cash.
- v. The value of the Gift Voucher will not be entitled to sales volume accumulation.
- vi. A minimum sales volume of 500 must be accumulated in a single order to utilize the Gift Voucher for purchases. Amount deductible begins from US\$50 and can only be applied in denominations of US\$50, please refer to the table below for the criteria of utilizing the Gift Voucher to offset purchases.
